





On a desktop/laptop device the webcast will appear at the side automatically.


On a mobile device, select the broadcast icon at the bottom of the screen to watch the webcast.

6 During the meeting, mobile users can minimise the webcast at any time by selecting the arrow by the broadcast icon. You will still be able to hear the meeting. Selecting the broadcast icon again will reopen the webcast.



Desktop/laptop users can watch the webcast full screen, by selecting the full screen icon **I**. To reduce the webcast to its original size, select the X at the top of the broadcast window.

When the Chairman declares the poll open:

- A voting icon **II** will appear on screen and the meeting resolutions will be displayed
- To vote, select one of the voting options. Your response will be highlighted
- To change your vote, simply select a different option to override

There is no need to press a submit or send button. Your vote is automatically counted. Votes may be changed up to the time the Chairman closes the poll.


