**DIVIDEND INVESTMENT PLAN ALLOCATION PRICE FOR 2022 FINAL DIVIDEND**

Wesfarmers Limited today announced that the allocation price for shares to be issued through the Dividend Investment Plan for the final dividend to be paid in respect of the period ended 30 June 2022 is \$45.8581.

The allocation price for shares to be issued has been determined in accordance with the rules of the Dividend Investment Plan. For the 2022 final dividend, the allocation price was calculated as the average of the daily volume weighted average price of Wesfarmers Limited shares, excluding trades which are not considered to reflect normal supply and demand, on each of the 15 consecutive trading days during the period from 6 September 2022 to 27 September 2022 inclusive.

Based on audited data, shareholders representing 12.24 per cent of Wesfarmers Limited quoted shares on issue had a valid election to participate in the Dividend Investment Plan for the period.

Shares are expected to be issued to participants in the Dividend Investment Plan on 6 October 2022.
