# QUARTERLY STATEMENT OF PRODUCTION, DEVELOPMENT AND EXPLORATION

## **1 APRIL TO 30 JUNE 2014**

## **CURRAGH**

#### **Production**

Overburden removal was 15.5 per cent higher than the previous quarter largely due to the timing of the planned 11 week major dragline shutdown which was completed in April 2014.

Coal production for the quarter was 3,334,000 tonnes (comprising 2,406,000 tonnes of metallurgical coal and 928,000 tonnes of steaming coal), 4.0 per cent higher than the previous quarter. Metallurgical coal production increased by 1.3 per cent and steaming coal production increased by 11.8 per cent compared to the previous quarter.

For the 12 months to 30 June 2014, metallurgical coal production increased by 19.4 per cent to 8,810,000 tonnes and steaming coal production increased 7.5 per cent to 3,498,000 tonnes. The prior comparable period was impacted by a scheduled mine shutdown in December 2012/January 2013 and wet weather associated with Cyclone Oswald in early 2013, with average metallurgical coal production of 8,095,000 tonnes recorded during the respective 12 month periods to 30 June 2013 and 30 June 2014.

## **Development**

There was no significant development activity during the quarter.

### **Exploration**

There was no significant exploration activity during the quarter.
